to prevent others from posting bills or advertisements thereon, except such as shall first be approved by the Lessor, as aforesaid.

9. The Lessee shall not locate or place, or permit to be located or placed, any luilding, structure, fixture, or material of any kind, nearer than six feet from the nearest rail of any track of the railroad; - - and the Lessee shall not located, erect or maintain, or permit to be located, erected or maintained, any beams, pipes, wires, structures or other obstruction over the tracks of the railroad, or any of them, at a height of less then twentythree feet above the top of the rails of said tracks, or any of them. The Lessee here'w covenants and agrees to assume, and to protect, save harmless and indemnify Lessor from and against all loss, damages and expenses in consequent of death of or injury to persons, and loss or deset truction of or damage to property, caused or directly contributed to by reason of the violation by Lessee of any of the provisions of this paragraph; and any such violation shall work an immediate forfeiture of this lease without notice, but such forfeiture, or any termination of this lease, shall not release the Lessee from any liability or obligation assumed by the Lessee horeunder.

10. In consideration of the privileges hereby given the ressee to occupy and use the ground of the Lessor hereinabove described, and of the benefits and privileges to be derived therefrom, and of the rental herein provided, Lessee hereby covenants and agrees to assume all damages resulting from want or failure at any time of title on the part of lessor to any part of the leased premises, and all damages resulting from fire communicated from the right of way, locomotives or other machinery of the Lessor, or otherwise, to any buildings, structures, improvements or other property of any kind or character that may now or hereafter be upon said leased premises, or any part thereof, and to whomsoever the same may belong, and all damares resulting from death of or injury to the Lessee, or any of Lessee's agents, servants or employes, and any and all other persons, while upon said leased premises, or any part thereof, and loss or destruction of or damage to any buildings, structures, improvements or other property of any kind or character that may now or hereafter be upon said leased premises, or any part thereof, and to whomsoever the same may belong, caused by or resulting in any manner from the operation or maintenance of said railroad; whether any such damage shall be caused by the negligence of Lessor, or any of its agents, servants, or employes or otherwise. Lessee hereby further covenants and agrees to release, and does hereby release, and to protect, save harmless and indemnify, Lessor from and against any and all damages in this paragraph referred to, and all claims, demands, causes of action, suits, judgments, attorneys' fees, costs and expenses on account thereof.

11. In further consideration for the making of this lease, Lessee hereby covenants and agrees to protect, indemnify and save harmless Lessor from and against all damages, claims, demands, causes of action, suits, judgments, attorneys' fees, costs and expenses sustained or incurred by Lessor, resulting from fire communicated from any building, structure, improvement or other property located on said leased premises, or any part thereof, to any car or cars which may have been placed on any track or tracks of the railroad, and to the contents thereof, and to any and all other property, and resulting from injury to or death of persons and loss or destruction of or damage to property, caused in any manner by any acts or emissions, negligent or otherwise, of the Lessee, or any of Lessee's agents, servants or employes.

12. Should it be contemplated or occur that an overhead pipe, swinging arm or other conveyor, be used by the Jessee in loading oil from tanks or reservoirs on the domised premises into cars on the tracks of the Lessor, or from the caro on the tracks of the Jessee into tanks or reservoirs located upon the demised premises, then, and in that event, the Lessee shall not leave the tank cars connected with such device except during the times when at loost one employee of the Lessee shall be in charge, and the Lessee shall and does hereby agree to indemnify
