TO HAVE AND TO HOLD THE SAME, together with all rents and profits therefrom and with all and singular the tenoments, hereditaments and appurtenances thereunto belonging, or in anywise appertaining and all rights of homestead exemption unto the said party of the second part, and to its successors and assigns forever.
