This mortgage is given to secure the principal sum of ONE THOUSAUD ## Dollars, with interest thereon at the rate of ten per cent. per annum payable semi-annually from date according to the terms of four (4) certain promissory notes described as follows, to-wit:

One note of \$500.00; one note of \$300.00; two notes of \$100.00 each, all dated February 2nd, 1925, and all due in three years.

Said first parties agree to insure the buildings on said premises for their reasonable value for the benefit of the mortgages and maintain such insurance during the existence of this mortgage. Said first parties waive notice of election to declare the whole debt due as above and also the benefit of stay, valuation or appraisement laws.
