A strip of ground, not to exceed ten (10) feet in width, being more particularly described as follows, to-wit:

The West ten (10) feet of Lot 9, Block 17, Resubdivision of Block 6, Terrace

Drive Addition to the city of Tulsa, Oklahoma, according to the duly recorded

plat thereof.
