

COMPARED

to First Party whether as the result of Judicial proceedings, or settlement, or compromise, for rents and profits, issues and profits, or royalties in said lands, or any part thereof, or for oil, gas, coal, or other mineral extracted therefrom, or for damages thereto, or as to the value thereof; said sum or sums to be due and payable at the time of such recovery, settlement or compromise; to secure said John L. Ward Second Party, the compensation herein stipulated it is expressly agreed that said John L. Ward shall have, and he is hereby granted by said First Party a lien upon the interest of said First Party in said lands, as the same now exist, or shall hereafter be determined and upon the amounts claimed by said First Party for rents, issues and profits, or for royalties on said land or for the value thereof, or for oil, gas, coal or other mineral extracted therefrom, and also upon any and all sums of money, or other things of value that may be paid, or agreed to be paid to First Party upon any of the claims herein before referred to.

It is further agreed between the parties hereto that this Contract may be recorded in the office of the County Clerk, Ex-officio Recorder of Deeds of Tulsa County, Oklahoma, and that any petition filed in Court in this matter shall be indorsed "LIEN CLAIM" so that any compromise, settlement or dismissal of the same shall not affect the rights of the Second Part hereto.

This Contract shall be in full force and binding upon the parties hereto, their heirs, executors, administrators, and assigns, until its object or purposes shall have been accomplished or the rights and claims of First Parties shall have been finally adjudicated by the courts or have been compromised or settled and the terms of this contract fulfilled.
