WARRANTY DEED COMPANY, S.W. 1/4, 1925

This Indenture, Made this 10th day of January, A. D., 1925, between

Witnesseth: That in consideration of the sum of Five Thousand and No/100

DOLLARS, the receipt whereof is hereby acknowledged, said parties of the first part do hereby these presents grant, bargain, sell and convey unto said party of the second part, her heirs and assigns, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:

The South Forty feet (S40') of North Sixty-one (N61') feet of Lot Six (6) of Block One (1), in Highlands Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat and survey thereof.

To Have and To Hold the Same, Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, forever.

And said Parties of the First Part for themselves and their heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the second part that at the delivery of these presents, that they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance in fee simple, of and in all and singular the above granted and described premises, with the appurtenances; that the same are free, clear and discharged and unincumbered of and from all former and other grants, titles, charges, estates, judgments, taxes and assessments and incumbrances of whatsoever nature and kind, EXCEPT, a certain first mortgage in favor of the Tulsa Building and Loan Ass. as shown of record and all taxes and special assessments hereafter to mature.
