This mortgage is given to secure the principal sum of \_\_\_\_\_

DOLLARS,

with interest thereon at the rate of 8 per cent, per annum, payable semi- annually from date

according to the terms of One certain promissory note \_\_\_\_\_ described as follows, to-wit:

One note for the principal sum of \$540.00 made and signed by the above named mortgagors due and payable to the above named mortgagee or order, said note dated the 21st day of April, 1923 and due and payable in monthly installments of \$15.00 per month, the first monthly installment of \$15.00 being due and payable on the 21st day of May, 1923 and a like monthly installment of \$15.00 being due and payable on the 21st day of each succeeding month until said principal sum with interest shall have been fully paid. Failure to pay any sum when due principal or interest shall cause all the sums of money hereby secured to be immediately due and payable at the option and election of the owner and holder hereof, without notice. This mortgage is given subject to a first mortgage of Home Building and Loan Association Sand Springs, Oklahoma in the sum of \$2000.00.

Provided, always, that this instrument is made, executed and delivered upon the following conditions, to-wit: That said first parties hereby covenant and agree to pay all taxes and assessments of said land when the same shall become due, and to keep all improvements in good repair and not to commit or allow waste to be committed on the premises, and to insure, and keep insured in favor of second party, buildings on said premises.

It is further expressly agreed by and between the parties hereto that if any default be made in the payment of the principal sum of this mortgage or any interest installment, or the taxes, insurance premiums, or in case of the breach of any covenant herein contained, the whole of said principal sum, with interest, shall be due and payable, and this mortgage may be foreclosed and second part V shall be entitled to the immediate possession of the premises and all rents and profits thereof.

Said parties of the first part hereby agree, that in the event action is brought to foreclose this mortgage, they will pay a reasonable attorney's fee of Fifty DOLLARS, which this mortgage also secures.

Parties of the first part, for said consideration, do hereby expressly waive appraisalment of said real estate and all benefit of the homestead, exemption and stay laws in Oklahoma.
