within five days thereafter, furnish to it, at its office in Thuron. Pa., a true and accurate statement of the financial condition of the Vendee, showing all its assets and liabilities specifying with reasonable detail the nature and character of each thereof, and verified by the Vendee, or one of them, if there be more than one, or by the Treasurer of of the Company if the Vendee be a corporation.

19. No failure uponthe part of the Vendor to immediately enforce any rememby hereunder by reason of any default on the part of the vendee shall be a valver of any of the rights of the Vendor upon such default or upon any subsequent default or in any wise impair or affect the title of the Vendor reserved by this agreement, and, notwithstanding any such failure, delay or omission on the part of the Vendor assert any right hereunder, it may, at any time, assert any or all of its remedies with respect to said default or any subsequent default, as though the same had been the first default and had then immediately occured.

20. This agreement shall be binding upon the varties hereto, and upon their respective successors and asciens; and wherever the terms "Vendor" and ""Vendee" are in this agreement used, they shall be a natived to cover the respective successors and assigns of said Vendor and said Vendoe.
