occupied for any purpose except residence purposes; and that no duplex house, flat or apartment building, or business building of any kind or description, shall be erected or monstructed on said lots or either of them.

The building restrictions created and imposed herein, shall be and are hereby made binding on all of the parties hereto, their heirs, executors, administrators and assigns, and are enforcible by any of the parties hereto, either by the remedy of injunction to prevent the violation thereof, or by suit for damages, in the event of a violation thereof.
