Newton and assigned by her endorsement upon the back thereof, but that no "Assignment of Mortgage" has been executed by her conveying such security; that the persons who have purchased said notes are entitled to an assignment of the mortgages securing the same.

It is therefore ordered by the Court that said Executrix be and she is hereby authorized and directed to execute, acknowledge and deliver to the respective purchasers of all of such notes so assigned by the said G. W. Newton, during his life time, or assigned by said Executrix after the death of snid G. W. Newton, an "Assignment of Mortgage" according to the form presecribed by the laws of soid State of Oklahoma, assigning to such respective purchasers the mortgage securing the notes assigned to them respectively.
