LEASE

This lease, made this 14th day of March 1922, by and between H. S. Corliss of the first part, and Tulsa Oil Products Company, of the second part:

Witnesseth, That said first party in consideration of the covenants and agreements hereinafter set forth does by these presents, demise, lease and let unto the second party the following described property, situated in the County of Tulsa, State of Oklahoma, to-wit:

The South Twenty Five (25) feet of the East Eighty Five (85) feet, of Lot Numbered Three (3) and the East Eight Five (85) feet of Lot numbered Four (4) in Block Numbered One Hundred and Forty Eight (148), Original Town of the City of Tulsa.

To have and to hold the same to the second party from the 16th day of March, 1922 to the 16th day of March 1925, and said Second party, in consideration of the premises here in set forth, agrees to pay to the first party as rental for the above described premises the sum of \$250.00 per month from the 16th day of March 1922, to the 1st day of May 1922, payable in advance, from the 16th day of March to the 1st day of April 1922, half month, and in advance from the 1st day of April 1922, to 1st day of May, 1922 and from the 1st day of May 1922 to the end of the lease at the price of \$400.00 per month payable in advance on the 1st day of May 1922 and on the 1st day of each month thereafter.
