AGREEMENT, Made and entered into 7th day of April 1923 by and between Bell Wilson et al party of the first part, hereinafter called lessor (whether one or more) and W. L. Kendall, part--- of the second part, hereinafter called lessee.

WITNESSETH, That the said lessor, for and in consideration of -----DOLLARS cash in hand paid receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of the lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, pwers, stations and strucures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa, State of Oklahoma, described as follows, to-wit:
