## SUPPLEMENTAL CONTRACT

COMPARED

THIS AGREEMENT, made and entered into this 21st day of April, A.D., 1923, by and between C. E. BEYL, a single man, and JOHN L. BEYL and ELLA BEYL, his wife, by and through their attorney in fact, C. E. BEYL, parties of the first part, and T. B. COULTER and CHAS. B. BEITEL, parties of the second part;

WITNESSETH:

WHEREAS, the parties hereto have executed the said contract, which is hereto attached and made a part hereof as fully as though set out at length herein; and

WHEREAS, parties hereto desire to modify the same in the following particulars, to-wit:

For the consideration therein named it is agreed by and between the parties hereto that the above described premises is subject to a certain oil and gas mining lease, an undivided one-eighth (1/8) of which said lease is now held and owned by J. N. Shilling. Parties of the first part hereby agree and bind themselves to secure from the said J. N. Shilling an assignment of all of his right, title, interest and estate in and to said oil and gas mining lease and oil and gas mining rights within 10 days from the date hereof.
