GENERAL WARRANTY DEED.
(Corporation Form)

COMPANY

THIS INDENTURE, made this 26th. day of February, A.D. 1923, between TERRACE DRIVE COMPANY, a Corporation, organized under the laws of the State of Oklahoma, of Tulsa County of Tulsa, State of Oklahoma, party of the first part, and EARLE G. HASTINGS party of the second part.

WITNESSETH: That in consideration of the sum of Twelve Hundred Fifty (\$1,250.00) Dollars, the receipt whereof is hereby acknowledged, said party of the first part, does by these presents grant, bargain, sell and convey unto said party of the second part, his heirs, executors or administrators, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:

of the SubDivision of Blocks Two (2)
Three (3) and Seven (7) of Terrace
Drive Addition to the City of Tulsa,

according to the recorded plat thereof.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining forever.

And said TERRACE DRIVE COMPANY, a corporation, its successors or assigns, does hereby covenant, promise and agree to and with said party of the second part at the delivery of these presents that it is lawfully seized in its own right of an absolute and indefeasible estate of inheritance in fee simple, of and in all and singular the above granted and described premises, with the appurtenances; that the same are free clear, and discharged and unincumbered of and from all former and other grants, titles charges, estates, judgments, taxes, assessments and incumbrances, of whatsoever nature and kind. EXCEPT, general and special taxes for the year 1918 and subsequent years, and it is further agreed between the parties hereto that this lot is sold for residence purposes only and no dwelling shall be erected thereon to cost less than Four Thousand (\$4,000.00) no part of which shall be nearer than the front lot than twenty (20) feet, and that said Corporation will warrant and forever defend the same unto said party of the second part his heirs, executors, or administrators, against said party of the first part their successors or assigns, and all and every person or persons whomsoever, lawfully claiming or to claim the same.
