AND IT IS FURTHER AGREED that upon a breach of the warranty herein or upon a failure to pay when due any sum, interest or principal secured hereby or any tax or assessment herein mentioned, or to comply with any requirements herein, the whole sum sec red hereby shall at once and without notice become due and payable at the option of the holder hereof, and shall bear interest the reafter as hereinbe ore provided, and the said party of the second part or assigns shall be entitled to a foreclosure of this Mortgage and to have the said premises sold and the proceeds applied to the payment of the sums secured hereby; and that immediately upon the filing of
