WITNESSETH: That the said lessor, for and in consideration of One and no/100 pollars, cash in hand paid, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on part of lessee to be paid, kept and performed has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying of pipe lines, and of building tanks, powers, stations and structures there on to produce, save and take care of said products, all that certain tract of land situate in the County of Tules Sta te of Okla described as follows, to-wit:
