EXTENSION OF OIL AND GAS MINING LEASE.

COMPARED

WHEREAS, heretofore on the 5 day of Aug 1922, J.W. Boles, and Mable Boles, Husband & wife executed, acknowledged and delivered to W. R. Gard an oil and gas mining lease covering the following described property situated in Tulsa County, Oklahoma, to-wit:

NOW THEREFORE, for and in consideration of the sum of One Dollar, receipt of which is hereby acknowledged, the undersigned lessors mentioned in the oil and gas mining lease above described, do hereby and by these presents extend the time for the commencement of said well to the 15th day of December 1922; that all terms and considerations of said oil and gas mining lease shall remain in full force and effect except that in the clause wherein it is recited that said well shall be commenced at the date therein mentioned, said date is hereby changed and extended to read December 15th 1922.

CONTRACT FOR DEED

COMPARED

THIS CONTRACT made and entered into this 9th day of February, 1923, by and between C. H. Goggeshall of Tulsa, Oklahoma, hereafter referred to as first party, and T. C. Laughlin of Tulsa, Oklahoma, hereafter referred to as second party, Witnesseth;

THAT WHEREAS, first party is the owner of Lots Four (4) and Five (5), Block One (1) in Bell Addition to the City of Tulsa, Tulsa County, Oklahoma,

AND WHEREAS, there is the sum of Five Hundred Dollars (\$500.00), due on the purchase price of said property.

AND WHEREAS, second party has agreed to make payments on such unpaid balance in the sum of Twenty-five Dollars (\$25.00) on the first of each and every month beginning with March 1, 1923, and the interest on each Twenty-five Dollar (\$25.00) payment is to be paid at the date of payment of such payment; such interest to be computed on the basis of 8% from
