the premises herein described is attached or questioned, that the lessor will permit such legal procedure as may be necessary and expedient, to be conducted in the name of said lessor, at the expense of the said lesson, and that said lessor will give the said lessee their assistance and co-operation to insure the rights of the said lesses.

As indicated above, if the estate of either party hereto is assigned, the covenants herein shall extend to their heirs, executors, administrators, successors or assigns, but no change in the ownership of the land or the loase shall be binding on either party until the other party has furnished them with a true copy of the transfer or assignment thereof.

Lessor hereby warrant and agrees to defend the title to the lands herein described, and agrees that the lesses shall have the right at any time to redeem for lessor, by payment of any mortgages, taxes or other liens, on the above described lands, in the event of default of payment by lessor, and be subrogated to the rights of the holder thereof.

It is mutually understood and agreed between the parties hereto, that lessor reserves and shall have the right to convey water from the Arkansas River over or through the premises here in leased to lessee, in such manner as shall not interfere with the efficient operation of the plants of the lessee.
