ASSIGNMENT OF OIL AND GAS MINING LEASEHOLD RIGHTS.

THIS INSTRUMENT, executed this 23 day of February, 1923, by H. G. Hotchkiss and J. R. Hall, assignors, to the various parties hereinafter named, as assignees, WITNESSETH
