Order Confirming Sale of Real Estate

Now on this 10th day of March, 1923, the same being one of the regular days of the county court of Bryan County, Oklahoma, inprobate, came on for hearing the return and account of sale of Rose A. Wade, guardian of the above named minor, and the matter being submitted to the court upon the evidence oral and documentary and the court being well and sufficiently advised in the premises therefrom finds:

That pursuant to the order of this court made on the 1st day of February 1925, the guardian of the above named minor duly advertised the property herein described for sale by posting and publication in Tulsa County, Oklahoma, for the time and in the manner required by law as is fully shown by the proof of posting and publication on file in this cause; that said guardian caused the property herein described to be appraised by the appraisers heretofore appointed by this court, and that said appraisement is now on file herein. Wade be and the same is hereby in all things approved, confirmed and declared valid and that said guardian upon the payment of the purchase money is hereby ordered and directed to deliver to said purchaser a good and sufficient deed of conveyance, conveying said property to him.
