ASSIGNMENT OF MORTGAGE

McCullough, in consideration of the sum of Twenty three hundred & no/100 Dollars, to him in hand paid, the receipt whereof is hereby acknowledged, does hereby sell, assign, transfer, set over and convey unto W. H. Rogers of Tulsa, Oklahoma, successors or assigns, one certain mortgage dated the 15th day of September 1921 executed by Montana Springer and J. M. Springer, her husband, to Grant R. McCullough, upon the following described property, situated in the county of Tulsa Oklahoma, to-wit:
