I further depose, and state, that said rental has not been received by me, or deposited to my credit in the said Oklahoma National Bank, as provided in said lease, therefore according to the tenor of, and terms stipulated in said lease, the contract has thru the failure of said Oklahoma-Texas Producing and Refining Co., their successors, executors, administrators, and assigns, to pay said rental, become null and void, and all their rights, titles and interests by virtue of said lease has therefore become void.

226621 C. J. COMPARED OIL AND GAS LEASE

AGREEMENT, Made and entered into the 20th day of March 1923, by and between A. T. Free, and Laura Free his wife of Skiatook Oklahoma party of the first part, hereinafter called lessor (whether one or more) and Chas W. Stepp, party of the second part, lessee.

WITNESSETH, That the said lessor, for and in consideration of One Hundred Sixty and no/100 DOLLARS, cash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa state of Oklahoma, described as follows, to-wit:

The Southwest Quarter, (SW $\frac{1}{4}$ ) of the Southeast Quarter, (SE $\frac{1}{4}$ ) of Section fourteen, (14) Township Twenty-two, (22) North, and Range Twelve, (12) East of the Indian Base and Meridian
