WITNESSETH, That said parties of the first part, in consideration of the sum of One Dollar and other good and valuable considerations to them duly paid, the receipt of which is hereby acknowledged have quit claimed, granted, bargained, sold and conveyed, and by these presents do for themselves, their heirs, executors and administrators, quit claim, grant, bargain, sell and convey unto the said party of the second part and to his heirs and assigns, forever, all of their right, title, interest estate claim and demand both at law and equity in and to all the following described property, to-wit:
