I, S. R. TRAVIS, being first duly sworn, depose and state: That I am the same person as the S. R. Travis named as one of the grantees in a deed dated October 2, 1920, and executed by LIONEL B. Z. AARONSON, conveying:

The North Half (N $\frac{1}{2}$) of the South east quarter (SE $\frac{1}{4}$) and the Southwest Quarter (SW $\frac{1}{4}$) of the southeast quarter (SE $\frac{1}{4}$) of Section Thirteen (13), Township Nineteen (19) North, Range

Twelve (12) East, in Tulsa County, Oklahoma ;

shown of record in Book 312, at page 222 of the title records of Tulsa County, Oklahoma, in which the grantees were M.M. Travis and S. R. Travis. That by instrument dated the 4th day of April, 1921, recorded in Book 363, at page 266 of the title records of Tulsa County, Oklahoma, I, joined by my wife, Julia Travis, deeded an undivided one-half interest in the lands above described to Rhea Travis, Trustee, That the Rhea Travis, named as grantee in said deed, is the wife of M. R. Travis, my brother .

That the total consideration paid for the execution of said deed was paid to me by M. R. Travis, whom I understood was to be in fact the owner of said land, and who directed me to make the deed to the said Rhea Travis, Trustee, in order that the record title to said property might be free from the lien of a certain judgment then pending against the said M. R. Travis; that in the negotiations culminating in the execution of the deed last above described, M. R. Travis alone appeared and had negotiations with me.

I further depose, and upon oath state, that I know no one by the name of J. C. Gerson, and never heard of such a person to my knowledge. That Julia Travis, my wife, who signed the deed last above mentioned with me, had no part in the transaction, and simply signed the deed to satisfy any requirement as to conveyance of an interest in the homestead, if any homestead rights should have attached to said land thereby conveyed.
