ASSIGNMENT OF OIL AND GAS LEASE

WHEREAS, On the 15th day of March, A.D. 1919, a certain oil and gas mining lease was made and entered into by and between Ross H. Rayburn, Lessor, and Sand Springs Home, a corporation, Lessee, covering the following described land in the County of Tulsa, and State of Oklahoma, to-wit;

WHEREAS, on the 7th day of August, 1908, a certain oil and gas mining lease was made and entered into by and between Jennie Bruner, lessor, and W.A. Springer and E.R. Minshall, lessee, covering the following described land in the County of Tulsa, and State of Oklahoma, to-wit;

Northeast Quarter (NE $\frac{1}{4}$ ) of Southeast quarter (SE $\frac{1}{4}$ ) of Section Six (6), Township Nineteen (19) North, Range Twelve (12) East, ( and other land ). said lease being recorded in the office of the County Clerk of said County in Book 53, page 4, and in Book 255, Page 149; and

WHEREAS, On the 6th day of April, 1910, a certain oil and gas mining lease was made and entered into by and between Mary Partridge, lessor and W.A. Springer; E. R. Minshall, J.F. Sweeney and R. N. Koblegard, lessees, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit;

Northwest Quarter (NW $\frac{1}{4}$ ) of Southwest Quarter (SW $\frac{1}{4}$ ) of Section Five (5) Township Nineteen (19) North, Range Twelve (12) East. said lease being recorded in the office of the County Clerk of said County in Book \_\_\_\_, page \_\_\_\_; and

WHEREAS, The said leases and all rights thereunder or incident thereto, so far as they cover an undivided one-eighth interest in the lands described, are now owned by Gladys Belle Oil Company, a corporation, subject to the terms and conditions of a certain contract entered into between Mary Oil and Gas Company and J.E. NOW THEREFORE, For and in consideration of One Dollar (\$1.00) and other good and valuable considerations, the receipt whereof is hereby acknowledged, the undersigned, Gladys Belle Oil Company, a corporation, does hereby bargain, sell, transfer, assign and convey unto J.E. Fitz-Patrick and P.K. French, their heirs and assigns, all its right, title and interest in and to the oil and gas leases above described so far as said leases cover the lands above described, and all its right, title and interest in and to the fixtures, equipment and materials thereon, subject to the contract and supplements thereof mentioned in the paragraph next above.
