

COMPARED

a straight line to a point which is located twenty-nine (29) feet south of the said north line of the Mitchell tract; thence southwesterly in a straight line one hundred ten (110) feet to a point which is seventy-nine (79) feet south of the said north line of the Mitchell tract; thence southwesterly in a straight line fifty-eight (58) feet to a point which is one hundred nineteen (119) feet south of the said north line of the Mitchell tract; thence southwesterly thirty-two (32) feet to a point which is one hundred forty-six and twenty-five hundredths (146.25) feet south of the said north line of the Mitchell tract; thence southwesterly eighteen (18) feet in a straight line to a point which is one hundred fifty-seven (157) feet south of the said north line of the Mitchell tract; thence westerly one hundred fourteen and four-tenths (114.4) feet on a line one hundred fifty-seven (157) feet south of and parallel to the said north line of the Mitchell tract; thence northwesterly in a straight line ten (10) feet to a point which is one hundred forty-six and twenty-five hundredths (146.25) feet south of the said north line of the Mitchell tract; thence westerly on a line one hundred and forty-six and twenty-five hundredths (146.25) feet south of and parallel to the north line of the Mitchell tract four hundred seventy-seven (477) feet to the point of beginning.
