CONTRACT.

THIS CONTRACT, made and entered into this 7th day of September, 1922, by and between H. R. Standlee, party of the first part, and B. and C. Machine and Foundry Company, a corporation, party of the second part, WITNESSETH;

WHEREAS the party of the first part has perfected an improvement in an oil well swab, and is now seeking to have the same patented in the United States Patent Office at Washington, D.C., which application for patent is pending under serial No. 582500; and

WHEREAS the party of the second part is desirous of securing the sole right to manufacture and sell said article throughout the United States upon the terms and conditions hereinafter agreed upon;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements hereinafter contained, the parties hereto have stipulated and agreed as follows:

FIRST. Party of the second part has this day appropriated and paid party of the first part on account of advance royalties the sum of Two Hundred and O/100 (\$200.00) Dollars, and agrees to expend further sums in manufacturing, advertising and marketing Said swab. Party of the second part agrees that, for a term of one (1) year from this date, it will advertise said swab once a month in the Purchasing Agents Bulletin, and once every three months in the National Petroleum News; provided said publications continue throughout the year; and will, as soon as a swab is manufactured exhibit the same at the purchasing agent's store-room in the city of Tulsa, Oklahoma, throughout the year; provided said storeroom is maintained for that length of time. Party of the second part will put forth its best effort to manufacture said swab in a good and workmanlike manner, and advertise and promote the sale thereof throughout the life of this contract, and, in the event it becomes necessary, will provide for the manufacture of swabs in other shops than the foundry and machine shop of the party of the second part.

SECOND. Party of the second part, in consideration of the rights and privileges granted to it, agrees to pay the party of the first part, his heirs, personal representatives, or assigns, a royalty of Twenty-five (\$25.00) Dollars for each of said swabs manufactured and sold and fifteen (15) per cent, of the gross selling price
