## RELEASE OF OIL AND GAS LEASE

WHEREAS a certain oil and gas lease dated July 2, 1914, recorded in book 171, page 21 of the records of Tulsa County, Oklahoma, By Robert Fry and Cornelia Fry his wife and Lawrence Fry a single man to Joseph Ardizzone and F.J. Ossenbeck, covering the following land in Tulsa County, Oklahoma, to-wit;

North half of the Southeast Quarter and the Southeast Quarter of the Southeast Quarter of Section 25, Township 18 North, Range 13 East, covering a period of three years from date and as long thereafter as oil or gas is produced on said premises, and

WHEREAS the said lessees above named assigned a portion of the same by assignment dated July 3, 1914, to A. L. Farmer and A.E.Duran, which said assignment is recorded in Book 171, page 65 of the records of the County Clerk of Tulsa County, Oklahoma, and

WHEREAS the lessees and assigns together with one T.M. Barnsdall by assignment dated October 5, 1915, conveyed a portion thereof to the Caney River Gas Company, a corporation, and

WHEREAS the said lease has now expired and the same was never developed for oil and gas purposes by said lessees, assigns or either of them the same should therefore be released and cancelled as it constitutes a cloud on the lessor's title.

Now Therefore, in consideration of the terms of said lease, together with the forfeiture of all rights conveyed thereunder, the said foregoing parties, to-wit;

A partnership consisting of Joseph Ardizzone and F.J.Ossenbeck, A.L. Farmer and A.E.Duran, both jointly and severally do hereby release, remise and quit-claim, and set over unto the said lessors aforesaid, their heirs, assigns and legal representatives, all their right, title and interest that they or either of them, jointly or severally may have obtained by virtue of said lease or the assignments made thereunder, to have and to hold the same forever.
