ORDER APPROVING REPORT OF COMMISSIONERS AND CONDEMNATION OF LANDS FOR SCHOOL PURPOSES

Now on this 19th day of July, 1921, the report of the commissioners heretofore appointed herein coming on for approval, and The Board of Education of the City of Tulsa, of the State of Oklahoma appearing by its attorneys and C.C. De-la Hunt appearing by J.P. Clark, his attorney, and it appearing to the Court that due and legal notice was given of the filing of the petition by the said The Board of Education of the City of Tulsa of the State of Oklahoma for the condemnation for school purposes of lands owned by C.C. De la Hunt, the same being described as follows, to-wit;

Lots 1, 2 and 3 in Block 20 in Owen Addition to the City of Tuisa, Tulsa County, Oklahoma,

and it further appearing that commissioners were duly appointed to appraise said lands and to assess the damage of the said C,C. Dela Hunt, the owner thereof, on account of the appropriation of said lands by the said The Board of Education of the City of Tulsa of the State of Oklahoma for shoool purposes, and that said commissioners have filed herein their report wherein they assessed the damage of the said owner at the sum of \$16,000.00, which sum has been paid into the office of the Court Clerk of this County by the said The Board of Education of the City of Tulsa of the State of Oklahoma; and it further appearing that the said C.C.
