All those certain lots or pieces of ground, situate in the twenty-third (23rd) ward of the City of Pittsburgh, County of Allegheny, bounded and described as follows, to wit:

Beginning on the eastwardly side of Anderson Street, (Sixty feet wide) at the northwardly line of land of Anna Gaytons McCarthy, the same being a distance of Forty-two feet, nine and one fifth inches (42 ft. 9-1/5 in.) more or less, northwardly of the north line of East Lacock Street (Fifty feet wide); thence northwardly along the eastwardly side of said Anderson Street Forty (40) feet, to the southwardly line of land of Henry J.
