WITNESSETH: That the parties of the first part in consideration of the sum of One Hundred (\$100.00) Dollars) to them in hand paid, the receipt whereof is hereby acknowledged, as well as the agreements and mutual covenants hereinafter mentioned, does hereby bargain, sell and convey unto the party of the second part, his heirs and assigns for a period of Five (5) years, all the coal in, under and upon the following described real estate and premises, situate in Tulsa County, State of Oklahora, to-wit:

> Northwest Quarter of the Southeast Quarter of the Northwest Quarter of Section 22, Township 20, North, Range 13 East, according to the U.S.Survey thereof, and containing Ten (10) acres, more or less.
