Lot Seven (7) a distance of Eighty (80) feet; thence Northwesterly parallel with and One (1) foot distant Northeasterly from said Westerly boundary line of said Block to the place of beginning. Intending to convey the Easterly Eighty (80) feet of the Westerly Eighty-one (81) feet of said Lots Seven (7), Eight (8), Nine (9), Ten (10) Eleven (11) and Twelve (12) in said Block One Hundred Twenty-one (121).

129. MILK CONDENSERY. All those certain lots, pieces or parcels of land situate in the City of Bloomer, County of Chippewa and State of Wisconsin, known and described as follows, to wit:

First Parcel:

That part of the Southeast Quarter (SE $\frac{1}{4}$) of Section Five (5) Township Thirty (30) North of Range Nine (9) West, described as follows:

Beginning at a point on the West line of Gilbert Street Nineteen and Sixty-hundredths (19.60) feet North of the point of intersection of the South line of said section Five (5) with the said West line of Gilbert Street; running thence North along the West line of Gilbert Street One hundred forty-five and Forty-Hundredths (145.40) feet, said point being Ten (10) rods north of the South line of said section Five (5); thence West on a line parallel with and One hundred Sixty-five (165) feet North of South line of said Section Five (5) Five hundred seventy (570) feet more or less to the Easterly shore line of Mill Pond; thence Southerly along Easterly shore line of said Mill Pond to a point on a line parallel with and Nineteen and Sixty hundredths (19.60) feet North of the South line of said Section Five (5); thence East along last mentioned parallel line Five hundred fifty-four (554) feet more or less to the place of beginning.

Second Parcel:

Lots numbers Three (3) and Four (4) and that part of Lot number Two (2) described as follows:--Commencing at the Northwest corner of said Lot, running thence South on the West line thereof one hundred twenty-four (124) feet; thence East on the South line thereof forty (40) feet; thence in a Northeasterly direction to the Northeast corner thereof; and thence West on the North line thereof sixty-six (66) feet to the place of beginning all in Block number Seven (7) of the original plat of the Village of Bloomer, and all subject, however, to the right of R.D. Marshall and A.B. McDonald, their lessees or assigns, to use the street immediately North of said lots for the maintenance and operation of the railway spur track now situated thereon.

Also that part and parcel of Lots numbers Five (5) and Six (6) in said Block number Seven (7), described as follows: Commencing at the Northwest corner of said Lot number Five (5), thence east along the North line of said Lots, One hundred Fifteen (115) feet, as near as may be to the concrete division wall now thereon; thence South along said wall and parallel with the west line of said lots, Forty-two (42) feet; thence West along said party wall and parallel with the South line of said lots Nineteen (19) feet; thence South along said wall and parallel with said West line, Eighty-two (82) feet, as near as may be, to the South line of said lots; thence West along said South line to the Southwest corner of said lot number Five (5);
