130. BRANCH HOUSE. All that certain lot, piece or parcel of land situate in the City of Kenosha, County of Kenosha and State of Wisconsin, known and described as follows, to wit:

Part of the Southwest quarter of section number Thirty-one (31) in Township number Two (2) North, of Range Twenty-three (23) East, and being also a part of Lots four (4) and Five (5) of Block number Four (4) of Fisk's Addition to the City of Kenosha, and commencing at a point on the East line of said Block Four (4) which is One hundred and Forty-one (141) feet North of the Southeast corner of Lot Six (6) Block Four (4) of Fisk's Addition; thence West on a line parallel with the South line of Lot Six (6) Ten (10) rods; thence North on a line parallel with the East line of said Block Four (4) to the South line of the track of the Kenosha, Rockford and Rock Island Railroad Thirty (30) feet more or less, thence following the line of said track as it curves Easterly to the East line of said Block Four (4); thence South on the East line of said Block Four (4) Fifty-six (56) feet more or less to the place of beginning, and being in the fourth ward of the City of Kenosha, in the County of Kenosha, and State of Wisconsin.
