138. CHEESE WAREHOUSE. All that certain lot, piece or parcel of land situate in the City of Richland Center, County of Richland and State of Wisconsin, known and described as follows, to wit:

Twenty-six (26) feet in width off North side of Lot Number One (1), Block Number Five (5), Richland Center, Wisconsin, subject to six (6) feet in width off West end of same for alley.

139. MILK CONDENSERY All that certain lot, piece or parcel of land situate in the City of Stoughton, County of Dane and State of Wisconsin, known and described as follows to wit:

All of the following described lots, pieces or parcels of land situate ⁱⁿ lying and being the Southeast Quarter (SE $\frac{1}{4}$) of Section Five (5) Township Five (5) North Range Eleven (11) East, in the City of Stoughton, Dane County, Wisconsin, being parts of Lots Sixteen (16), Seventeen (17), Eighteen (18), Nineteen (19), Twenty (20), Twenty-one (21), Twenty-two (22), Twenty-three (23) and Twenty-four (24) of Block Six (6) O.M. Turner's Addition to Stoughton, Wisconsin, more particularly described as follows:

Beginning at the intersection of the south line of Ridge Street, as extended; with the Easterly line of Lot Sixteen (16) aforesaid; thence North Eighty-nine Degrees Thirteen Minutes (89 13') West along said south line of Ridge Street extended Two Hundred Sixty-four (264) feet; thence North Twenty-nine Degrees (29) West, along the Southwesterly side of a right-of-way, belonging to the City of Stoughton, Four Hundred Sixty-five (465) feet to an iron stake, situated Four (4) rods from the Southeast bank of the Catfish River; thence South Sixty-one Degrees Fifteen Minutes (61 15') West One Hundred Forty-two (142) feet to a point in the Northeasterly line of the right-of-way of the Chicago, Milwaukee & St. Paul Ry.; thence South Twenty-nine Degrees (29) East along said Northeasterly line of the Chicago Milwaukee & St. Paul Ry. right-of-way Six Hundred Eleven and Five-tenths (611.5) Feet to the Northwest corner of the depot grounds; thence South Sixty-seven Degrees FOUR Minutes (67 4') East Seventy-six and Three-tenths (76.3) feet; thence North Sixty Degrees and Fifty-five Minutes (60 55') East One Hundred Four (104) Feet to the Northeast corner of the depot grounds thence South Twenty-nine Degrees (29) East to the intersection of the Northeast line of the depot grounds with the East line of Lot Sixteen (16) aforesaid; thence North along the said East line of Lot Sixteen (16) to the place of beginning; together with all trackage rights of the grantor, also the right to the use of a strip of land One (1) rod wide, running Northwesterly across Lot Twenty-three (23) aforesaid, from the above described land to the Catfish River, the same to be used for laying sewer pipes or drains; also the right to take ice from any place on the Southeasterly, Southerly and Southwesterly sides of the center of the main channel of the said Catfish River, between the intersections of said River by the Northeasterly line of the right-of-way of said Railway and the Westerly line of Lot Fourteen (14) extended Northerly to the intersection of the center of the main channel of the Catfish River; together with any other rights.
