CONTINENTAL AND OCEANIC

AND WHEREAS, the coupon bonds and registered bonds of any series other than
bonds of Series A are to be substantially in the forms above set forth with suitable
variations as permitted by this Indenture, and with or without such guaranty en-
dorsed thereon; and

WHEREAS, all the requirements of law relating to the authorization of the aforesaid
issue of bonds and the execution of this Indenture and the mortgage and pledge
thereby evidenced, all as in this Indenture provided, have been complied with and
observed, and all things necessary to make said bonds when executed by the Company
and authenticated by the Corporate Trustees and delivered, the valid, binding and
legal obligations of the Company, and to make this Indenture a valid, binding and
legal mortgage and deed of trust for the security thereof, have happened, and have
been done and performed, and the issue of said bonds and the execution of this
Indenture have in all respects been duly and legally authorized;

Now, Therefore, this Indenture witnesseth: that for and in consideration of the
premises and of the purchase and acceptance of the bonds by the holders thereof, and
of the sum of One Hundred Dollars and other good and valuable considerations
duly paid by the Trustees at or before the execution and delivery of this Indenture
the receipt whereof is hereby acknowledged, and in order to secure the due and punctu-
al payment of the principal and interest of all bonds which shall be issued here-
under, the Company hath executed this Indenture, and hath granted, bargained, sold,
aliened, remised, released, enfeoffed, warranted, conveyed, confirmed, assigned,
mortgaged, pledged, delivered, transferred and set over, and by these presents
doth grant, bargain, sell, alien, remise, release, enfeoff, warrant, convey, con-
firm, assign, mortgage, pledge, deliver, transfer and set over unto the Trustees,
their and each of their successors in this trust and their and each of their
assigns, the following described lands, buildings, machinery, fixed equipment, &
tools and other appurtenant properties, bonds, obligations and other properties,
real, personal and mixed, hereinafter sometimes collectively referred to as the
mortgaged property or premises or as the trust estate, to wit:

Clause 1.

All and singular the following lands, and interests in lands, upon which this
Indenture is a first mortgage and lien:

ALABAMA.

1. BRANCH HOUSE. All that certain lot, piece or parcel of land situate in the
City of Anniston, County of Calhoun and State of Alabama, known and described as
follows, to wit:

That tract of land known and designated on the map of the Anniston City Land
Company as part of Lots One (1) Two (2) Three (3) Four (4) Five (5) and Six (6)
in Block One Hundred and Fifty-nine (159), the land hereby conveyed fronting
Fifty (50) feet on the West side of Moore Street, and running back One Hundred
and Fifty-four (154) feet more or less, on the South line, and One Hundred and
Sixty-four (164) feet, more or less, on the North line, as shown on the plat
attached to the Deed from the Anniston City Land Company to Armour Packing Com-
pany, bearing date the 25th day of May 1900, and recorded in the office of the
Probate Judge of said Calhoun County on the 15th day of June 1900, in Book
