extend within ninety feet of the front lot line or within 50 feet of the side street line that no part of the lot or lots hereby conveyed shall ever be sold or rented or occupied by any person of African descent known as negroes; provided, however that the building of a servants' house to be used only by servants of the owner or lessee of the lot or lots here by conveyed shall not be a violation of the last restriction hereinabove written; that the houses to be erected on this lot shall be not less than 2 stories; and any violation of these restrictions or any one thereof shall work a forfeiture of the lands hereinconveyed unto the grantor herein, its successors and assigns).

DOES BY THESE PRESENTS grant, bargain, sell and convey unto said part of the second part, his heirs or assigns, all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit: Lot One (1) in Block Sixteen (16) in Riverside Drive Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the amended plat thereof now on file in the office of the County Clerk (ex-officio Register of Deeds) within and for Tulsa County, Oklahoma.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.
