PARTY WALL AGREEMENT

COMPARED

ARTICLES OF AGREEMENT Made and entered into this 16 day of June, 1920, by and between R. J. Greenwood, party of the first part, and Ed. Fox, party of the second part, WITNESSETH:

WHEREAS, said party of the first part is the owner of lot Eighteen (18), in block Eleven (11), at Skiatook, Oklahoma; and,
