That the party of the first part, for and in consideration of the sum of Two Thousand (\$2,000.00) Dollars, to him in hand paid by party of the second part, the receipt of which is hereby acknowledged, has remised, released and quit-claimed, and by these presents does hereby remise, release and quit-claim to party of the second part, an undivided one-eighth interest in and to a certain oil and gas mining lease and leasehold estate thereunder, executed on or about June 14, 1922 by W. R. McKee and wife to Flesher Petroleum Company, covering Lot Three of Section 12, Township 18 North, Range 12, East, containing 29.67 acres in Tulsa County, Oklahoma, the same being all the interest the grantor has in said lease and leasehold estate and the premises covered thereby.
