KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, heretofore, to-wit: On the 27th day of January, 1923, G. C. Spillers and Lorena M. Spillers, husband and wife, made, executed and delivered to the First National Bank, of Tulsa, Oklahoma, a mortgage to secure the payment of a note for the sum of \$5500.00; which said mortgage covered the following described real estate in the City of Tulsa, Tulsa County, Oklahoma, to-wit:
