ORDINANCE NO. 2383

An Ordinance accepting and adding to the City of Tulsa, Oklahoma, a certain tragt of land known as NORTH DENVER ADDITION to the CITY OF TULSA, TULSA COUNTY, OKLAHOMA; according to the

WHEREAS, a petition in writing has been presented to the Mayor and Board of Commissioners of the Wity of Tulsa, Oklahoma, signed by the property owners of the tract of land herein described and designated as North Denver Addition to the City of Tulsa, Oklahoma, said tract of land being in Tulsa, County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City, which petition prays that said Board annex to said City of Tulsa, said tract of land; and,

WHEREAS, it has been made to appear upon examination by said Board of that the tract of land herein described is platted into lots and blocks and is used for residential purposes, and it further appearing to said Board that the prayer of said petitioners should be granted and the land embranced in said petition, should be annexed to said city and that all things necessary to be done for the proper annexation of said tract of land ub saud City have hoppened and been performed, and that said action is for the henefit of all parties concerned. NOW, THEREFORE, BE IR ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, STATE OF OKLAHOMA.

SECTION 1. That a tract of land hereinafter described, the same being known as NORTH DENVER ADDITION to the City of Tulsa, Oklahoma, and adjoining the present corporate limits of said City, being more particularly described as follows, to-wit:
