A strip of ground, not to exceed ten (10) feet in width, as shown by the blue prints on file in the City Engineer's office of Tulsa, said strip, being more particularly described as follows, to-wit:

The North ten (10) feet of Lot 22, Block 3, amended Terrace Drive
