A strip of ground, not to exceed ten (10) feet in width, as shown by the blue prints in the City Engineer's office of the City of Tulsa, said strip, being more particularly described as follows, to-wit:

The North ten (10) feet of Lots 24, 25, 26, 27, 28, 29, 30, and 31

Block 3, amended Terrace Drive of Blocks 2-3-7 of Terrace Drive Addition

to the City of Tulsa, as shown by the duly recorded plat thereof.

for the purpose of permitting the City of Tulsa to construct a sewer line thereto, through, over, under and across said property, together with all necessary and convenient appurtenances, thereto; and to use and maintain the same, and of affording the City of Tulsa, its officers, agents, employees, and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying, excavating, for, laying, constructing, operating, repairing, relaying and maintaining said sewer line and for the further purpose of enabling the City of Tulsa, to do any and all necessary and convenient things, incident to such construction, operation, repairing, and maintaining of such sewer line.
