AGREEMENT, Made and entered into the 27th day of March, 1923 by and between D. B. Layton and his wife Annie Layton of Broken Arrow, Okla. hereinafter called lessor (whether one or more), and Thomas F. Griffin hereinafter called lessee;

WITNESSETH: That the said lessor, for and in consideration of One Dollar, cash in hand paid, paid, the receipt of which is hereby acknowledged, and of the covenants and agreements herein after contained on part of lessee to be paid, kept and performed has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying pipe lines, and of building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa, State of Okla described as follows, to-wit:

Lots Two (4.21 acres) and Lot Three (37.10 acres) all in Section

Thirteen, Township Seventeen North, Range Fourteen East. of Section

13, Township 17 Range 14 and containing 41.35/100 acres. more or less,

It is agreed that this lease shall remain in force for a term of 5 years from this date, and as long thereafter as oil or gas or either of them is produced from said land by lessee.

In consideration of the premises the said lessee covenants and agrees:

1st. To deliver to the credit of lessor, free of cost, in the pipe line to which he may connect his well, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor one eighth of all the proceeds from the gas sold for the gas from each well where gas only is found, while the same is being used off the premises, and if used
