of Oklahoma, said Oklahoma Union Railway Company being hereinafter referred to as the Vendor, the receipt of which payment is hereby acknowledged, the said Vendor has sold and by these presents does hereby bargain, sell and convey, and transfer, assign and deliver unto Public Service Company of Oklahoma, a corporation organized and existing under and by virtue of the laws of the State of Oklahoma, all of the following properties of said Oklahoma Union Railway Company, real, personal and mixed, tangible ^{and intangible} hereinafter mentioned and described, viz:

(a) The every right, privilege, franchise and enjoyment of said Vendor, by it owned or held under or derived from that certain Ordinance of the town of Red Fork, Tulsa County, Oklahoma, numbered Thirty-five (35) and adopted March 7, 1917, and ratified by the electors of said town at an election held April 16, 1917, whereby, among other things, there was granted to said Vendor and its successors and assigns a franchise to erect, maintain, extend and operate a system of work in said town for the purpose of furnished electricity for heat, light and power to the said town and its inhabitants, and whereby the said Town contracted with said Vendor and its successors and assigns for the furnished of heat, light and power to the said town. Express reference is hereby made to the records of the said Ordinance No. 35 in the office of the Town Clerk of said town for further particulars.

(b) The entire plant and distribution system of Vendor at the town of Red Fork, including, among other things, all poles, wires, cross arms, insulators, transformers, meters, and other machiner and equipment now owned by and used or owned and held for use by Vendor in connection with this electric business at the town of Red Fork and at the so-called Dog Racing Park, Sunset Plunge, Walters Junction, electric park, and all other territory adjoining, incident to, or served by Vendor's distribution system, except only such poles and equipment of Vendor as are located on the right of way of Vendor and used by it for the operation of its railway system.

(c). All materials, supplies and other chattels of every sort, whether in place or installed, owned by Vendor and used or held for use in the operation of its said electric lightning distribution system, in Red Fork and Vicinity

(d) The properties hereinabove mentioned and described under paragraphs numbered (b) and 900 shall be held to include, among other things, the following poles:
