and condition, as well as to the reservations, conditions and agreements hereinafter set out; the said seller further, excepting and reserving unto himself, his heirs and assigns, the oil, gas, fire clay, coal and all other minerals whether the existence thereof is now known or not, lying in and under the premises hereinafter described, does hereby bargain, sell, convey, and confirm unto the Furchaser, his heirs, successors and assigns, forever, the following described premises, situated in the town of Sand Springs, Oklahoma, County of Tulsa, State of Oklahoma, to-wit: Lot Number Five (5) Block Number Thirty (30) in Oak Ridge Second Additionto the City of Sand Springs according to the official plat thereof.

TO HAVE AND TO HOLD, the same together with all and singular the tenments, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and warrant the title to the same, unto the said purchaser, his heirs, successors and assigns, forever, subject nevertheless to the conditions and reservations and agreements hereinbefore set forth, according to the true intent and meaning thereof.
