WARRANTY DEED.

Witnesseth, that the said parties of the first part, in consideration of the sum of two thousand two hundred fifty and 00/100 dollars, the recept whereof is hereby acknowledged, and the further consideration and as a condition of this deed to which the grantee herein by accepting this ded assents and agrees: That the lot or lots hereby conveyed shall not within a period of ten years from this date be used for any other than residence purposes; that no store building, hotel, duplex house, flats or apartments shall be erected thereon during said period; that no residence that shall cost less than six thousand five hundred dollars shall be built on the lot or lots hereby conveyed; that one residence only shall be built on said lots; that no building or any part thereof, except steps or entrance approach without roof shall be built or extend with within 25 feet of the front line or closer then - - - feet of the side street line, and no garage, servants house or other subsidiary building shall extend within 70 fet of the front lot line or within - - - feet of the side street line; that no part of the lot or lots hereby conveyed shall ever be sold or rented to, or occupied by, any person of African descent known as negroes, provided, however, that the building of a servants house to be used only by servants of the owner or lessee og the lot or lots hereby conveyed shall not be considered as a breach of the conditions hereof; do by these presents grant, bargain, sell and convey unto said parties of the second part their heirs and assigns, all the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit: Lot five (5) and the east twenty five (25) feet of lot six (6) Block one (1) in Sunset View addition to the City of Tusa, Oklahoma, according to the recorded plat thereof duly recorded in the office of Register of Deeds within and for Tulsa County, Oklahoma,

To have and to hold the same, together with all and singular the tenements. hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said Thos. P. Melvin, J. H. Boyle and Van Leigh Boyle for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said parties of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance, in fee simple, of and in all and singular the above granted and described premises, with the appurtenances; that the same are free, clear and discharged and unincumbered of and from all,former and other grants, titles, charges, estates, judgements, taxes, assessments and incumbrances, of what nature rot kind soever, except taxes falling due after this date, and that they will warrant and forever defend the same unto the said parties of the second part their heirs and assigns, ggainst said parties of the first part their heirs, administrators, assigns, and all and every person or persons whomsoever lawfully claiming or to claim the same.
