Witnesseth, that for and in consideration of a loan of (\$5000.00) five thousand dollars, this day obtained from the second party as evidenced by note and mortgage of even date, the said party of the first part does hereby assignm transfer and set over to the said party of the second part, as collateral security for said loan, the rents and profits realized and to be realized during the period such loan is in force on the following described property in the County of Tulsa, State of Oklahoma, to-wit:

Lots thirty three (33) and thirty four (34)  
Block two (2) Orchard addition to the City  
of Tulsa, Oklahoma, according to the recorded  
plat thereof.

Said first party hereby agrees that said second party shall have the right to appoint an agent for the purpose of collecting the rents from said property, and the agent so appointed shall be entitled to a reasonable compensation from the rents collected for his services; and the said agent so designated by the second party shall be the agent of said first party for the purpose of collecting such rents. The said second party shall not be liable for any uncollected rents or for its failure to exercise its option in regard to the collection of the same.

Provided always, that if said first party shall pay or cause to be paid the regular monthly installment of the sum of (\$81.50) eighty one and 50/100 dollars, as provided by the note and mortgage executed in favor of said second party, and shall pay all taxes, assessments, insurance premiums, and any other lien than may be due or become due during the term of the said mortgage, then this assignment of rents shall be null and void; otherwise to remain in full force and effect.
