Sixth. I give and devise to the children of my deceased son, James Burris, the sum of fifty dollars to be divided equally among those surviving me.

Seventh. I give and devise to my daughter Bertha Heath of Sand Springs, the sum of fifty dollars.

Eighth, I give and devise to my wife, Florence A. Burris, all the rest, residue and remainder of my real and personal property, wherever situated.

Ninth. I hereby appoint and designate my wife Florence A. Burris sole executrix to act without bond, of this my lest will and testament.

In witness whereof, I, James Burris, have to this my last will and testament consisting of one sheet of paper, subscribed my name this 28th dayof January, 1921.
