CHEROKEE NATION, OKLAHOMA.

This indenture of lease, made and entered into in quadruplicate on this 3rd day of November, A.D. 1922, by and between Charles Whitefeather, a single and unmarried man, of Skitook, entolled as a full blood citizen of the Cherokee Nation, Roll No. 11130, patty of the first part her inafter designated as lessor, and J.W.R.Cmawford, Jr., of Tulsa, Oklahoma, party of the second part, hereinafter designated as lessee, under and in pursuance of the provisions of the Act of Congress approved May 27, 1908, (35Stat. L.P. 312) witnesseth:

1. The lessor, for and in consideration of one dollar, the receipt whemof is hereby acknowledged, and of the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed by the lessee, does hereby demise, grant, lease, and let unto the lessee, for the term of ten years from the date of the approval hereof by the Secretary of the Interior, and as much longer thereafter as oil or gas is found in paying quantities, all the oil de posits and natural gas in or under the following described tract of land, lying and being within the county of Tulsa and State of Oklahoma, to-wit: The

North half $(N_{\overline{2}}^{1})$ of the southwest quarter $(SW_{\overline{2}}^{1})$ of section fifteen (15) township twenty two north (22N) range thirteen east (13^{\pm}) .

of section - - township - - - range of the Indian Merkian, and containing 80 acres, more or less, with the exclusive right toprospect for, extract, pipe, store and remove oil and natural gas, and to occupy and use so much, only of the surface of said land as may reasonably be necessary to carry on the work of prospecting for, extracting, piping, storing, and removing such oil and natural gas, also the right to obtain from wells or other sources on said land by means of pipe lines or otherwise, a sufficient supply of water to carry on said operations, and also the right to use; free of cost, oil and natural gas as fuel period far as necessary to the development and operation of said property.

2. The lessee hereby agrees to pay or cause to be paid to the Superintendent of the Five Civilized Tribes, Muskogee, Uklahoma, for the lessor, as revalty, the sum of twelve and one-half per cent of the gross proceeds of all crude oil extracted from the said land, such payment to be made at the time of sale or removal of the oil. And the lessee shall pay as royalty on each producing well three hundred dollars per annum in advance, to be calculated from the date of comencement of utilization: Provided, however, in the case of gas wells of small volume, when the rock pressure is one hundred pounds or less, the parties hereto may, subject to the approval of the Secretary of the Interior, agree upon a royalty, which will become affective as a part of this lease; provided, further, that in case of gas wells of small volume, or where the wells produce both/oil and salt water to such an extent that the gas is unfit for ordinary domestic purposes, or where the gas from any well is desired for temporary use in connection with drilling and pumping operations on adjacent or nearby tracts, the lessee shall have the option of paying royalties upon such gas/of the same percentage of the gross proceeds from the sale of gas from such wells as is paid under this leacefor royalty on oil. The lessor shall have the free use of gas for domestic purposes in his residence on the leased premises, provided there shall be surplus gas produced on said premises over and above enough to fully operate the same.
