RENTAL CONTRACT.

This lease made and entered into this 14th day of April, A.D. 1923, by and between Jennie Shell, nee Eli, a Cherokee citizen opposite Roll No. 20485, of Stilwell, County of Adair, State of Oklahoma, party of the first part, and F. A. Blanck, party of the second part.

Witnesseth: That said party of the first part, of and in consideration for the sum of \$25.00 to her in hand paid, the receipt of which is hereby acknowledged, and other good and valuable considerations, do hereby rent and lease to the said party of the second part, F. A. Blanck, his heirs, successors, administrators, or assigns for agricultural and grazing purposes, for the full term of five years, beginning on the 1st day of May, A.D. 1923, and ending on the 30th day of April, A.D. 1928, the following described real estate and premises, situate in Tulsa County, State of Oklahoma, to-wit:
